Municipal Affairs - Grant Funding:

A letter was received from Municipal Affairs informing Council of our confirmed MSI Capital and Operating, plus the BMTG funding allotment.

Canadian Badlands Advertising:

#### **Old Business:**

Tree Plan/Parking Truck Route:

Council revisited the parking situation on the truck route. A letter was received from a group of citizens that would not want to see no parking on the south side of the truck route. Mayor DeVloo elaborated on his discussions with some of these citizens.

A possible solution may be to erect 15 minute unloading signs in front of the manor. Another solution may be to build a parking lot on the west side of manor 3. A third solution may be to expand the east parking lot and have a drop off at the east door. Mayor DeVloo will talk to the Paintearth Lodge to work together towards a compromise.

One Block of trees on the truck route has been cut down, two other blocks have been trimmed. Council was asked if we should cut down the remaining trees. Council would like to leave the remaining two blocks. A property owner on 50<sup>th</sup> Street requested that two trees be removed. One tree is in bad shape and can be removed.

Bylaw 1031 – Utility Bylaw:

The new Utility Bylaw 1031, a Bylaw to provide for the levying and collecting of charges and rates for utility services was presented to Council. Changes reflected in the Bylaw are the \$1.00 increase in the garbage service and an increase in water charges to coincide with the rate increase from SMRWSC. The Bylaw was given first reading at the March 24, 2014 Council meeting.

Based on this report they have suggested that an approximate cost of the lagoon cleaning would be about \$35,000.00. They are prepared to do the job at the end of October this year.
